(PROPOSED) ORDER ADOPTING AMENDMENTS TO CHAPTER 4-71A,  
HAWAII ADMINISTRATIVE RULES, aka MICROORGANISM IMPORT RULES,  
TO DELETE THE FUNGUS, BEAUVERIA BASSIANA GHA,  
FROM THE LIST OF RESTRICTED MICROORGANISMS (PART A)  
AND TO ADD BEAUVERIA BASSIANA GHA  
TO THE LIST OF NONRESTRICTED MICROORGANISMS

The Hawaii Board of Agriculture (Board), pursuant to section 150A-6.6, Hawaii Revised Statutes, section 4-71A-17, Hawaii Administrative Rules (Rules), and the Board's approval at its duly noticed meeting on (above date), hereby adopts the proposed amendments to: (1) delete the fungus, *Beauveria Bassiana GHA*, from the *Beauveria* genus listing on the List of Restricted Microorganisms (Part A) under section 4-71A-21, Rules; and (2) add the fungus, *Beauveria bassiana GHA*, to the List of

Nonrestricted Microorganisms under section 4-71A-24, Rules, as shown in the (proposed) exact changes to these lists appended as Appendix A-1 and A-2, respectively. This order is subject to the approval of the Governor, State of Hawaii, and the public notice requirements of section 4-71A-17, Rules, and shall take effect ten days after such notification.
